**NOTICE OF RACE**

**OPEN TO MEMBERS OF ANY YACHT CLUB**

**1. RULES:**

- 1.1 The series will be governed by the 'rules' as defined in the *Racing Rules of sailing 2017-2020*.
- 1.2 The YNZ Safety Regulations shall apply. - Keel Boats - Part II Category 5.
- 1.3 In accordance with YNZ Safety Regulations Part II 3.2, a declaration of safety compliance will be required in the entry form.
- 1.4 After the first race of the series any change of trim, sails, spars, variation to hull, rudder, keel or propeller must be declared on BBYC Declaration Form and lodged with BBYC Office by 1700 hrs on the Friday before the race.

**2. ELIGIBILITY AND ENTRY:**

- 2.1 The series is open to all Farr 1020 Keelboats that are skippered by a current member of the Farr 1020 Association.
- 2.2 Any boat entered in the BBYC PIC Insurance Winter Series (Full series or Windward Leeward Series) or Pine Harbour Winter series is entitled to automatic entry.
- 2.3 Entries will be accepted until 1700 hrs Wednesday 18<sup>th</sup> May 2017 by completing the attached entry form accompanied by a fee of \$40.00 and submitting to The Race Secretary, Bucklands Beach Yacht Club, P O Box 54 005, The Marina, Auckland 2144 or Fax 09 534 3242, or by completing online at [www.bbyc.org.nz](http://www.bbyc.org.nz).
- 2.4 To be eligible to complete in this series each skipper shall be a financial member of a club recognised by the skipper's national authority.
- 2.5 A minimum of six (6) boats must be entered before 1700hrs Wednesday 18th May 2017 for the series to be run otherwise any entry fees received will be refunded.
- 2.6 Boats can select to enter in the open or restricted divisions which will all be run as a single division but handicapping adjustments will be made for boats that select restricted. The use of furling headsails is permitted provide the sail fits within the class rules.
- 2.7 New Sails must be signed off by the a class appointed measurer, sails that are older than 2 years can be declared class legal but must be presented for measuring at the end of racing if a protest is lodged over sail eligibility.

**5. RACING AREA:**

All races will be conducted in the area to the East or West of Browns Island.

**6. COURSES TO BE SAILED:**

The courses will be 6 Windward/Leeward Courses.

Courses are as per the BBYC General Course Sheet 2016/17 (Page 29 and 30 of the Yearbook). Non BBYC members can obtain their course sheet from the BBYC Office between 0830 hrs and 1700 hrs weekdays or by request at [racing@bbyc.org.nz](mailto:racing@bbyc.org.nz) before 1700hrs Wednesday 18<sup>th</sup> May 2017.

**7. SCORING:**

7.1 The Low Points Scoring System, Appendix A will apply.

7.2 Three (3) races will be required to be completed to constitute a series.

7.3 No score will be excluded when calculating Series Results.

**8. PRIZES:**

The Farr 1020 cups will be presented for first on Line and Handicap plus prizes as determined by entries at the prizegiving.

Prizegiving will be held at the Farr 1020 Annual Dinner in November 2017.
